Covid Vaccination Consent form

- All forms for residents of Riverwood Square have been pre-filled on site.
- Families and residents are **NOT** required to fill out a consent form.
- If your family member requires additional support in completing the consent form Management will contact the family directly. You will receive a consent form thru docusign for completion via email. You DO NOT need docusign to complete the form.

Enhanced Consent Form

- Is **ONLY** required if resident is suppressed due to disease or treatment or if they have an auto immune condition. Family will have to contact: Lindsay Girouard lgirouard@riverwoodsquare.com. If this form is required Lindsay will forward that consent form thru Docusign for completion. You DO NOT need Docusign to complete.

Scheduling Update

Previously we had stated that a vaccine schedule would be distributed to families and residents. We have now learned that this will not be necessary. Residents will receive a time frame for vaccine window where they will be asked to sit outside their suite. Chairs will be provided. Staff will co-ordinate and facilitate all necessary reminders and logistics.

Adverse Reactions

“Oral analgesics or antipyretics (e.g., acetaminophen or ibuprofen) may be considered for the management of adverse events (e.g., pain, or fever respectively, if they occur after vaccination”.

Family should drop off any analgesics prior to Monday Please.

If reactions are severe, and we feel that additional supports are required, **WE** will contact family directly. Family member will have to meet all conditions required by Shared Health to access the building. Complete PPE protocols will have to be complied with.

Thank you to all that have replied to the call for volunteers. This request is **ONLY IN THE EVENT OF**-many individuals experiencing severe reactions to the vaccine. It is only then, that we would invoke this additional support.
